BY-LAW NO. 2015 - 21

BEING A BY-LAW TO AMEND BY-LAW 2008-113 AS AMENDED, BEING A BY-LAW FOR THE IMPOSITION AND COLLECTION OF FEES AND CHARGES FOR CERTAIN MUNICIPAL SERVICES AND ACTIVITIES

WHEREAS in accordance with Section 391 of the *Municipal Act, 2001*, S.O. 2001, c. 25, the Council of The Corporation of the Town of The Blue Mountains considers it necessary to impose fees for services rendered under these Acts;

AND WHEREAS the Council of The Corporation of the Town of The Blue Mountains has enacted By-law 2008-113 respecting Fees & Charges;

AND WHEREAS the Council of The Corporation of the Town of The Blue Mountains deems it necessary and expedient to amend By-law No. 2008-113 as amended respecting Fees and Charges.

NOW THEREFORE the Council of The Corporation of the Town of The Blue Mountains hereby enacts as follows:

- 1. THAT Schedule "H" of By-law 2008-113, as amended, be amended as per Schedule "H" attached hereto which is hereby declared to form part of By-law 2008-113, effective April 1, 2015.
- 2. THAT Schedule "I" of By-law 2008-113, as amended, be amended as per Schedule "I" attached hereto which is hereby declared to form part of By-law 2008-113, effective April 1, 2015.
- 3. THAT Schedule "K" of By-law 2008-113, as amended, be amended as per Schedule "K" attached hereto which is hereby declared to form part of By-law 2008-113, effective August 1, 2015.
- 4. THAT Schedule "L" of By-law 2008-113, as amended, be amended as per Schedule "L" attached hereto which is hereby declared to form part of By-law 2008-113, effective April 1, 2015.

AND FURTHER, THAT this By-law shall come into force and take effect upon the enactment thereof.
