LOCATION SKETCH

It is understood that all works will be constructed, altered, maintained or operated at the expense of the undersigned. The issuance of a Permit by the Town does not relieve the holder of the responsibility of complying with relevant municipal By-laws. In considerations of any permit issued in respect of the application, we, the agent/owner for ourselves, our heirs, executors, administrators, successors and assigns, hereby agree to observe, keep and perform and be subject to the regulations and conditions of said permit and to indemnify and save harmless, the Town of The Blue Mountains as represented by the Manager of Roads and Drainage or their designate, from and against all loss, cost, changes, damages, whatsoever to which may be put or which the Town may suffer or sustain or for which the Town may be liable by reason of anything done or omitted to be done in the construction, maintenance, alteration, or operation of the works authorized.

This agreement may be delivered by facsimile or by email in PDF format and such delivery shall constitute a duly executed original.

Conditions of Private Garbage Bin Placement

1. The private garbage bin must be located so that no part of the box protrudes onto the shoulder rounding of the road.

The private garbage bin shall be placed on one side of the laneway or the other at approximately 1 meter (3 feet) from the laneway at the property line. The private garbage bin shall NOT be located within the road ditch. The private garbage bin shall NOT be located on the back slope of the road ditch, and the private garbage bin shall NOT be located on the shoulder of the Town Roads.

2. The said private garbage bin shall be erected, placed, repaired and maintained so that:
 - a) The garbage bin shall not obstruct or obscure site lines of vehicles entering or leaving the laneway, or be an impediment, in itself or in its mountings, to affecting ready collection of garbage, or the continued maintenance of Town Roads.
 - b) Any designs that vary from a simple box configuration will only be permitted if they do not constitute a hazard and have been approved the Manager of Roads & Drainage or their designate.
3. The garbage bin owner is responsible to keep the garbage bin level and clear of snow and other obstructions at all times.
4. The garbage bin owner is responsible for all maintenance and repair, and all garbage bins must be kept in good repair and properly erected at all times so as to help minimize the possibility of becoming a traffic hazard by nature of its' design and construction.
5. The Town of The Blue Mountains, by its' employee(s), contractor(s), agent(s), owned equipment, rented equipment, leased equipment shall not be responsible for the replacement, maintenance, repair or otherwise to the said garbage bin and/or its' supports as a result of snow removal, maintenance or construction operations by the owner.
6. A private garbage bin placed, or caused to be placed on a Town Road Allowance is deemed to be a privilege and not a right.
7. This permit, issued by the Town of The Blue Mountains under the provisions of By-law # 2014-65 does not relieve the holder of that permit of the responsibility of procuring the permits or licenses required by other authorities under other Acts, Laws, or Regulations, etc. If during the life of the permit any By-laws or regulations are adopted which affect the privilege herein granted, the By-law or Regulations shall be applicable to this permit from the date on which they came into force.
8. This permit may be canceled at any time for the breach of the regulations or conditions of the Permit or for such reasons as the Town of The Blue Mountains in its discretion deems proper.

Enforcement

1. A private garbage bin placed, or caused to be placed on a Town Road Allowance is deemed to be a privilege and not a right.
2. A permit issued by the Town of the Blue Mountains under the provisions of By-law #2014-65 does not relieve the holder of that permit of the responsibility of procuring the permits or licenses required by other authorities under other Acts, Laws or Regulations, etc. If during the life of the permit any By-law or Regulations are adopted which affect the privilege herein granted, the By-laws or Regulations shall be applicable to this permit from the date on which they came into force.
3. The Town will notify owners of private garbage bins which are not in compliance with this policy. The owner will have Thirty (30) days from the time of notification, either verbally or in writing, to rectify the situation at his or her expense.
4. The Town has the option at the end of the Thirty (30) days period of either removing or relocating the offending garbage bin at the sole discretion of the Director.
5. A permit may be canceled at any time for breach of the regulations of the permit or for such reasons as the Town in its discretion deems proper.
