Notice of Public Meeting

Property Location: 549035 3rd Sideroad (South Part of Lot 4, Concession 6)

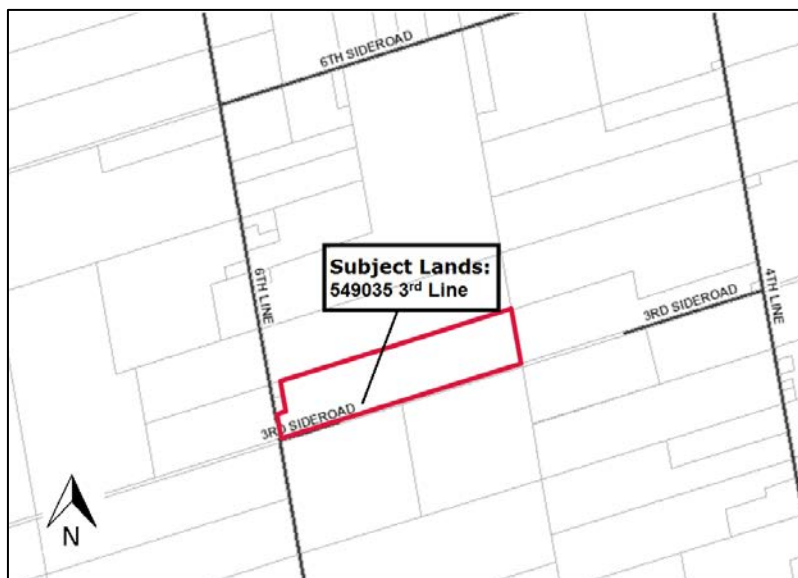

What is being proposed?

The applicants are seeking permission to establish a kennel on the property. The proposal is to rezone a portion of the property to add the use of "commercial kennel" through a site-specific exception to the property's Rural (RU) zone. The exception would also regulate the placement of kennel buildings and uses, limit the size of the use and number of dogs. One of the proposed kennel buildings is proposed to be located 2 metres from the property line adjacent to 3rd Sideroad (exterior side yard). The use of a shipping container for storage for the kennel is also proposed. The kennel use and buildings are to be established close to the existing dwelling and building cluster.

This proposal may also be subject to a separate Site Plan Control application.

The Town deemed this application to be a complete application, under Section of 34 (10.7) (a) the Planning Act.

When will a decision be made?

A decision on this proposal has NOT been made at this point and will NOT be made at the Public Meeting.

After reviewing the application and any comments received, Town staff will bring a recommendation on this project to a future council meeting.

Want to be notified of a decision?

You must make a request in writing if you wish to receive a notice of any decision of Council on this proposal.

Your rights to appeal a decision:

If a person or public body does not make oral submissions at a public meeting or make written submissions to Town of The Blue Mountains before the by-law is passed, the person or public body is not entitled to appeal the decision of Council to the Local Planning Appeal Tribunal.

If a person or public body does not make oral submissions at a public meeting, or make written submissions to Town of The Blue Mountains before the by-law is passed, the person or public body may not be added as a party to the hearing of an appeal before the Local Planning Appeal Tribunal unless, in the opinion of the Tribunal, there are reasonable grounds to do so.
