What is being proposed?

The Blue Mountains Council will be holding a Public Meeting to provide information to the public and to allow the public the opportunity to review and comment on the Draft Delphi Waterfront Management Plan.

Information and handouts will be available, with Town representatives in attendance to respond to inquiries and to receive comments from the public.

The Draft Delphi Waterfront Management Plan outlines the proposed access options for the Town owned waterfront at Delphi Point to protect the existing Areas of Natural and Scientific Interest (ANSI) at this location.

The proposed options include:

1. Installation of a Waterfront Trail Extension
2. No Permitted Access to the ANSI
3. Limited Permitted Access to the ANSI ("as is" scenario)

The information regarding the proposed options are described in the Draft Delphi Waterfront Management Plan.
