

C. Staff Reports

C.1 Detachment Commander's Report (verbal)

Sergeant Chris Maecker provided the board members with a detailed report for calls received by The Blue Mountains detachment for the last quarter from October to December 2018.

Sergeant Chris Maecker reviewed the 2018 Detachment Commander's Report for the 4th Quarter covering areas of staff hours to conduct R.I.D.E. programs, along with officers patrolling on foot, ATV, marine patrol and Snowmobiles.

Sergeant Chris Maecker noting the RIDE programs are escalating with the upcoming Christmas season, foot patrols have increase along with bicycle patrol at the Village into late fall. Chris noting that the snow machines are out on patrol weather permitted. Chris further noting the ATV's prove their use during the fall hunting season and long weekends in the Loree Forest area.

Sergeant Maecker reviewed with the Board the current staffing compliment, number of calls received by the Mental Health Response Unit, the schedule change for officers which is ongoing, continued engagement with the Collingwood Cycling Club, composition of the auxiliary unit, missing person investigation, break and enters.

Acting Inspector/Staff Sergeant Terry Ward noted the funding for mental health responses is provided by the Local Health Integrated Network (LHIN) and the United Way with shared social worker with Huronia West Detachment. Chair Jim Oliver questioned how long has the mental health initiative been in place and is the success being monitored. Acting Inspector/Staff Sergeant Terry Ward advised the initiative is going into the 3rd year, it is closely monitored, officers complete the one day mandatory training and they are very proud of this unit and its success.

Sergeant Chris Maecker notified the Board of an organization that has an outstanding bill for services provided by The Blue Mountains detachment for an event held in The Blue Mountains. Sergeant Chris Maecker advised that no services will be provided to the organization until the outstanding invoice is paid in full. The Board members agreed and are in support of their decision to hold the organization accountable to ensure payment is received prior to providing any future services. Interim CAO Shawn Everitt advised that no Special Events permit will be issued to this organization until payment has been received.

Board reviewed number of noise complaints and alarm calls that were attended by the officers on duty. Mayor Soever questioned how many calls for alarms are false alarms. Sergeant Chris Maecker replying that 95 % are false alarms. Board also reviewed the number of 911 calls. Board asked if The Blue Detachment could provide the members with a costing of false 911 calls. Sergeant Chris Maecker replying that this information can be provided to the members.
