### Application for Consent for Lot Addition

**Property Location: Part Lot 7, Concession 5, (vacant lot in Gibraltar)**

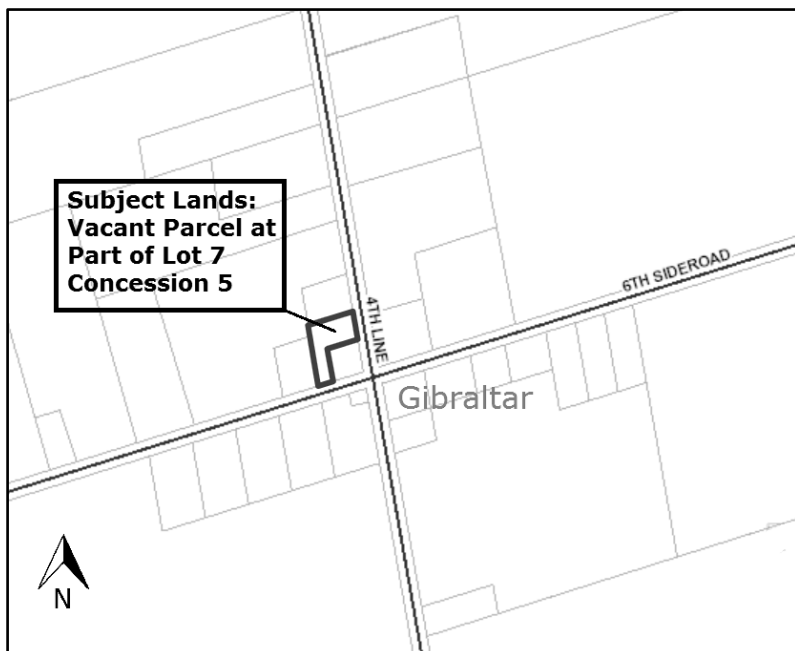
#### What is being proposed?

The property owners would like to sever a portion of the subject lot to add to the adjacent residential lot at 595374 4<sup>th</sup> Line. The change would make both lots into more regular lot shapes.

If this application is approved, the new reconfigured residential lot would then be 2148 square meters with 38 metres of frontage on 4<sup>th</sup> Line and 56 metres of frontage on 6<sup>th</sup> Sideroad. The retained lot would then be 1980 square metres, with 33 meters of frontage on 4<sup>th</sup> Line. Note that these measurements are approximate. Please see the other side of this notice for a severance sketch.

No other development is proposed at this time and both lots would continue to be zoned for detached residential uses in the Residential (R1-4) category.

The legal description of the subject property is Part of Lot 7, Concession 5, Part 2 of Reference Plan 16R1705 (formerly the Township of Collingwood), Town of The Blue Mountains.



#### What happens at a Public Meeting?

The public meeting is your chance to hear more about the proposal and make your views about it known. You may also speak at the meeting or submit written comments. Information from the public will help the Committee in their decision-making process, so make sure to have your say! After the public and agency comments are heard, the Committee will make a decision on the file.

Any person or agency may attend the Public Meeting and/or make verbal or written comments either in support or in opposition to the proposed amendment.

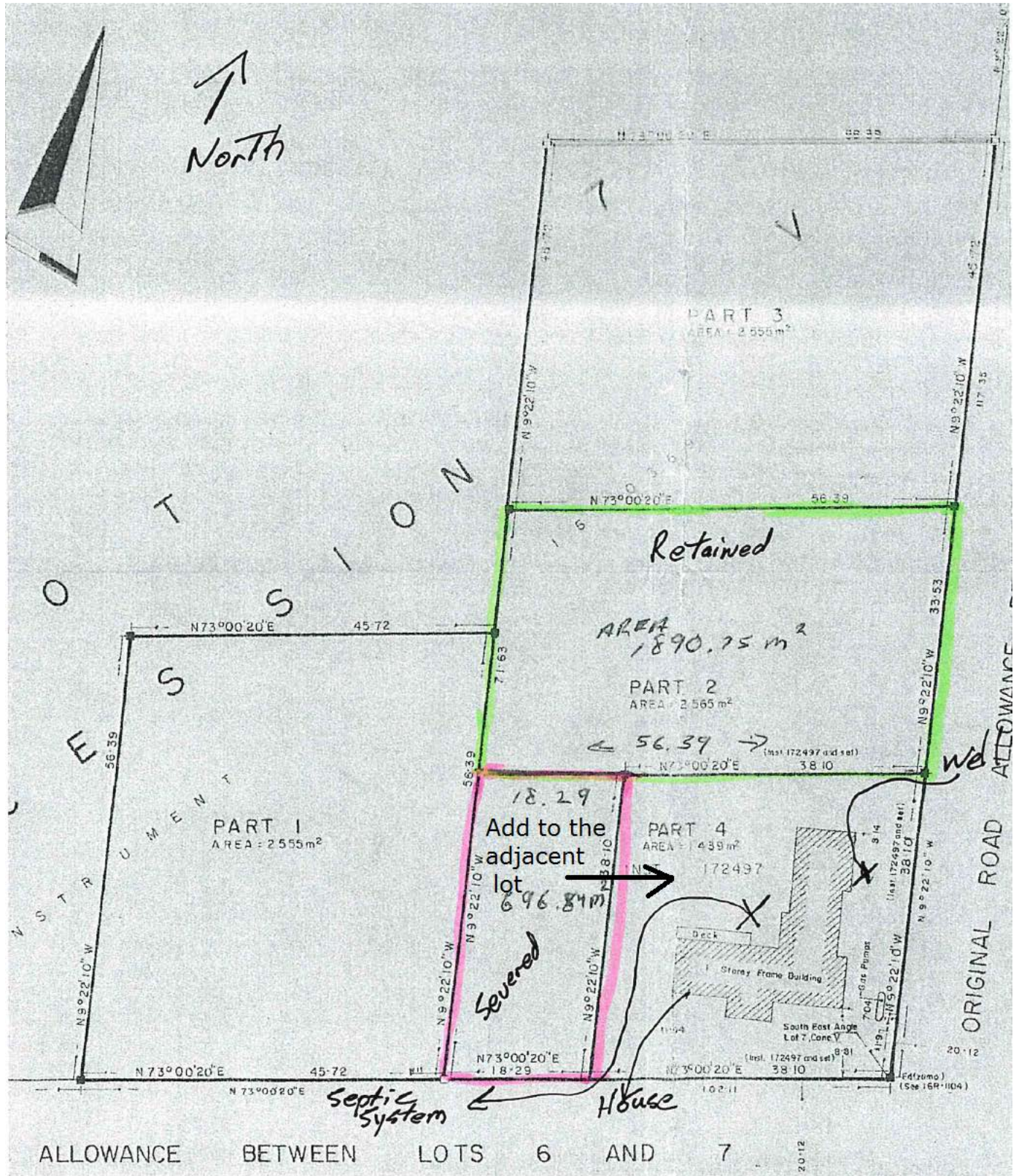
