What is being proposed?

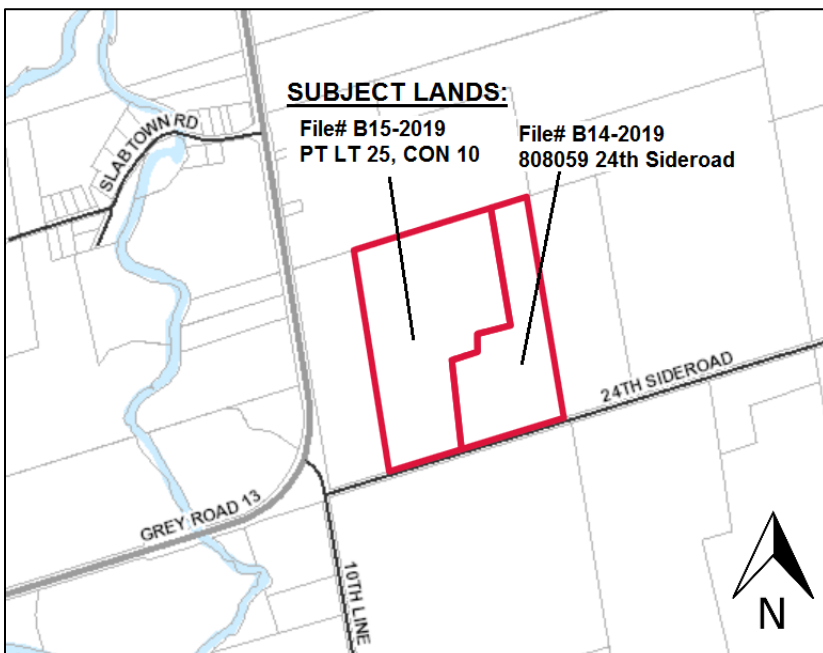
The owner of the subject lands has applied to adjust the lot lines between two agricultural lots:

- File# B14-2019 requests to Sever an irregular 0.189 ha vacant parcel with 23.3 m of road frontage to add to the lot to the west. The resulting lot would be 17.2 ha.
- File# B15-2019 requests to Sever an irregular 6.6 ha parcel with agricultural buildings and with no road frontage to add to the adjacent lot to the east containing a house. The resulting lot would be 11 ha.

Both subject lots have road frontage on the 24th Sideroad, with private water and sewage services. No new lots are proposed.

The purpose of these applications is to create more regular lot shapes and to bring the well which services the house onto the same lot with the house.

File# B15-2019: Part of Lot 25, Concession 10, and Parts 4-5 of RP16R10547 (formerly the Township of Collingwood).

If you wish to be notified of the decision of the Committee of Adjustment of the Town of The Blue Mountains with respect to the proposed consent, you must make a written request to Town of The Blue Mountains at the address provided above.

Your rights to appeal a decision:

If a person or public body that files an appeal of a decision of the Committee of Adjustment with respect to the proposed consent does not make written submissions to the Town of The Blue Mountains before a decision is made, the Local Planning Appeal Tribunal may dismiss the appeal.
