**By-law Number 2024 – 20**

**Being a By-law to Amend By-law 2013-42 Solid Waste Management Fees**

**Whereas** Subsections 5(3) and 11 (1) of the Municipal Act enable Council to pass Bylaws respecting matters within the sphere of waste management;

**And Whereas** the Council of The Corporation of the Town of The Blue Mountains has enacted By-law 2013-42 respecting Solid Waste Management Fees;

**And Whereas** the Council of The Corporation of the Town of The Blue Mountains considered amendments to the Solid Waste Management Fees By-law at the March 12<sup>th</sup>, 2024 Public Meeting;

**And Whereas** the Council of The Corporation of the Town of The Blue Mountains deems it expedient to revise Schedule “1”, as attached to the Solid Waste Management Fees By-law 2013-42;

**Now therefore** the Council of The Corporation of the Town of The Blue Mountains hereby enacts as follows:

1. **That** Schedule “1” as attached to By-law 2013-42 is hereby repealed and replaced in its entirety with the attached Schedule “1” to this By-law;

**And Further, that** this By-law shall come into force and take effect upon the enactment thereof.

#### Solid Waste Tipping Fees

Item	Description	Fee or Charge
<b>Residential</b>		
1.	Residential Waste (Waste that cannot be recycled or diverted from landfill)	\$190.00 per tonne
2.	Unsorted Residential Waste (Mixed with diversion items such as drywall, shingles, wood waste, brush, metal, concrete and other recyclables)	\$370.00 per tonne
3.	Divertible and Sorted Residential Waste (Clean drywall, shingles, metal, clean wood waste (including painted or treated), concrete, and other divertible items)	\$110.00 per tonne
4.	Recyclable Waste (Blue or grey box material, tires, electronic waste, municipal hazardous or special waste and textiles)	Free of Charge
5.	Residential Yard Waste and Brush: Placed in the designated area and free of non-conforming material	Free of Charge
<b>Commercial</b>		
6.	Commercial, Construction and Demolition Waste (Waste that cannot be recycled or diverted from landfill)	\$370.00 per tonne
7.	Unsorted Commercial, Construction and Demolition Waste (mixed with diversion items such as drywall, shingles, metal, wood waste, brush and other recyclables)	\$740.00 per tonne
8.	Sorted Commercial, Construction and Demolition Clean Drywall	\$160.00 per tonne
9.	Divertible and Sorted Commercial, Construction and Demolition Waste (Clean lumber, metal, clean wood waste (including painted or treated), concrete material, asphalt, shingles and un-contaminated soil)	\$110.00 per tonne
10.	Commercial Compostable Waste (Fruit Processing waste, brush and yard waste)	\$110.00 per tonne
11.	Chipped Brush (Commercial): Woody plant material less than 76mm (3 inches) in any direction, sorted in the designated areas	Free of Charge
12.	Recyclable Waste (Blue or grey box material, tires, electronic waste, textiles, Polystyrene)	Free of Charge
13.	Small Quantities of Waste Material	\$15.00 minimum visit fee
14.	Mattresses	\$25.00 per unit
15.	Contaminated Soil: Owner must provide documentation of certified testing results and obtain Town approval before delivery	\$220.00 per tonne
16.	Asbestos	Not Accepted
17.	Items with Freon: Refrigerators, Freezers, Air Conditioners and Dehumidifiers Certification Fee	\$15.00 each

5.	Green Bin (45 litre)	\$20.00 each
6.	Green Cart (Commercial/Multi Unit – 120 litre)	\$55.00 each
7.	Green Cart (Commercial/Multi Unit – 240 litre)	\$90.00 each
8.	Garbage Bag Tags <sup>1</sup>	\$5.00 each
9.	Garbage Box Tab	\$2.00 each
<b>Items for Reuse Area</b>		
10.	Small	\$5.00 each
11.	Medium	\$10.00 each
12.	Large	\$20.00 each

<sup>1</sup> For residential units the first bag is free, second bag requires one garbage bag tag, and the third requires two garbage bag tags. Three bags per residential units is the maximum allowed for weekly collection.
